## **II. Race Administration Projects and Goals**

A. Continue to improve both content and process of race official education and certification

- review course topics, supporting materials; update delivery methods to reflect needs of 21<sup>st</sup>-century learners
- develop seminar instructor guidelines and training: focus on making our instructors excellent teachers; standardize criteria for seminar instructor certification
- develop clear and efficient policies and processes for seminar registration and fulfillment
- develop continuing education recertification modules for experienced race officials
- online seminar testing
  - Completed: Club Race Officer
  - In process: Club Judge test scheduled for launch before year-end, Advanced Judge by end of January, Advanced Race by early spring
- bring Umpire course procedures and materials "into the fold"
- B. Develop standard policies for area race official representatives AROs, RAJs to handle their administrative responsibilities
- C. Work with area reps to identify regions where we need to cultivate and train more race officials
- D. Increase the number of race official seminars offered and the number of participants who attend them
- E. Develop course offerings and procedures to encourage young people to enter the race official track (a high school group, e.g.)
- F. Develop policy guidelines for responding at the area level to complaints of misconduct or incompetence by race officials, before such complaints rise to the level of Regulation 15 and the Review Board
- G. Rewrite US Sailing Regulation 10 in cooperation with Championship Committee to be presented to BoD on 12/18/14
