- 4. Continuing Education updates Bill Simon

The AJS is behind schedule. The roll-out seminar will be presented the end of January. Some of the clinics are going to be previewed at the College Nationals. Bill will send a synopsis of the clinics to the Committee members.

Nancy Glover stated that the round tables and "pop-up" round tables are doing well.

7. Background Checks (BCs)- Matt Hill

Matt discussed and clarified some of the background check policies including guidelines for privacy.

- Race Admin and Compliance are strongly recommending that US Sailing will cover all the costs for BCs
- 8. Guidelines for complaints/grievances against race officials Jim Walsh Matt Hill, Justin Sterk, Compliance Officer US Sailing, and Jim along with Randy Draftz, Chairman of the Race Administration Committee (RAC), are working on a guidance document for reports regarding certified officials while engaged in their role as a certified official. The document will comply with both US Sailing Regulations 4, 14 &15 and the Ted Stevens Act which is a US law. A draft of this document should be ready for the RAC next month. All the committees within the RAC will have the opportunity to vet the document.
- 9. Out of Area requirements for initial and recertification Rick Mallinson Proposed changes to the *US Sailing Judge Certification Requirements*:

#### 4.3 National Judge

#### a) Initial certification

Delete **4.3 a) 3) iii** which allows for exceptions to out of area events.

The motion was made, seconded and approved to accept the deletion. There was one opposed.

#### b) Renewal of certification

Change **4.3 b) 3) iii** to "At the discretion of the JC, a one-time exception may be made for a candidate who has served on six or more protest committees at the national or international level, of which fewer than two events meet the distance

requirement. This exception should be made for someone with extensive experience."

The motion was made, seconded and approved to accept the change. There were three opposed.
