Annual Meeting President's Report

As my final Annual Meeting as President, I would like to briefly reflect on the last 3 years and start by thanking our committee chairs and committee members and our 42,000 (and growing) members and member organizations who we serve.

Over the last 3 years, this Board in the midst of the COVID-19 pandemic has redefined our mission, reviewed and embraced our role as the National Governing Body of the Sport, created a strategic plan, strengthened the Athlete Voice with 5 athletes on our Board and endorsed our new Olympic Sailing strategy, Project Pinnacle.

Under Bill Ruh's leadership, we have strengthened the role of the US Sailing Foundation and broadened our philanthropic support. We are grateful for the continuing support of the sailing community and the growing number of donors who have gotten behind our vision for the future.
