AMENDMENT #1 TO THE NOTICE OF RACE

- 1) ADD the following to the title: US Sailing Men's and Women's Singlehanded Championship
- 2) ADD to the notation "[DP]" the following sentence at the end:
"World Sailing guidance for discretionary penalties will apply."
- 3) ADD to **1. RULES**, the following:
 - 1.5 For ILCA 6 and ILCA 7 competitors, [US Sailing Regulation 10](#) applies as the US Sailing Singlehanded National Championship.
 - 1.6 [DP] - each competitor shall wear a USCG approved life jacket that is 100% dependent on foam for flotation of at least 70N (15.7 lbs) and the appropriate size for the sailor, at all times while on the water, except for brief periods while adding or removing clothing.
 - 1.7 A: For adult US Sailing championship events, no competitor shall use or possess, either on or off the water: marijuana or any other substance if possession is illegal under state or federal law.
 - 1.7 B: For Junior and Youth events or for junior or youth competitors in any US Sailing championship, no participant or competitor shall use or possess, either on or off the water:
 1. marijuana or any other substance if possession is illegal under state or federal law; or
 2. any alcoholic beverages.
 - 1.7 C: An alleged breach of one of these regulations shall not be grounds for a protest; this changes rules 60.1(a), 60.2(a) and 60.3(a). However, when the protest committee believes that a competitor may have breached one of these regulations, it shall follow the process described in the Championships Code of Conduct. If a competitor is found to have breached one of the elements within the Code of Conduct, they shall be excluded from the remaining races of the series and, where practicable, removed from the regatta venue and sent home. When a competitor withdraws from part of an event pursuant to the Code, the scores of all completed races shall stand for the purposes of determining the seeding of subsequent rounds or stages in the event. However, that competitor's boat/team will US Sailing Regulations Page 17 Amended: 13-Nov-2021 no longer be eligible to compete in the event, shall be removed from the final event scores, and each boat/team with a worse finishing place in the event shall be moved up one place.

- 4) ADD to **6. ENTRY and ELIGIBILITY** the following:
- 6.7 Competitors who are also competing for the U.S. Singlehanded Championships must comply with [U.S.Sailing Championship Conditions](#) and [U.S. Sailing Singlehanded Conditions](#).
 - 6.8 In addition to the requirement described in 4.4, to be eligible to be scored in the U.S. Singlehanded Sailing Championship competitors must be at least age 17 in the calendar year of 2021, all competitors that are US citizens shall be members of US Sailing, and all non-citizen shall either be members of US Sailing or members of their World Sailing recognized MNA.
 - 6.9 When registering, those competing for the U.S. Singlehanded Sailing Championship must provide a current U.S. Sailing membership number.
- 5) ADD to **14. SUPPORT PERSONS AND VESSELS** the following:
- 14.4 [DP] All support boats shall carry a VHF radio capable of communicating on USA channels.
 - 14.5 US Singlehanded Championship is being held concurrent with the West Marine US Open Series. As such, the US Sailing Coaching and Support Boat Policy will not apply. This changes “Conditions for the US Singlehanded Championship”. Support vessels are allowed for this event subject to restrictions specified in the SIs.
- 6) ADD to **17. PRIZES** the following:
- 17.2 US SAILING SINGLEHANDED CHAMPIONSHIPS:
 - George D O’Day Trophy to the overall highest placing male in the ILCA 7 Class.
 - Helen Willis Hanley Trophy to the highest placing female in the ILCA 6 Class.
 - Peter J Barrett Sportsmanship trophy may be awarded.
 - US Sailing medals will be awarded to the top finishers in each fleet. Only U.S. citizens or resident aliens throughout the Championship Final event may be declared the U.S. National Champion in each fleet.

Explanation: These modifications have been made to incorporate the US Sailing Men’s and Women’s Singlehanded Championships for the Oday and Hanley Trophy.
