Recent additions to the <u>Judges page</u> Guidelines section are the updated Judges Certification Requirements (updated April 2022). This two-page PDF lists most but not all the requirements for certification and renewal as Club Judge, Regional Judge and National Judge. It is a much easier method to see the quantitative requirements than before.

Items added to the Useful Protest Committee Documents section include several WS Misconduct Hearing checklists.

Experimental Rule 18: The WS Racing Rules Committee has commissioned a Rule 18 Working Party made up of international sailors and rules experts to try and find ways to simplify rule 18 without significantly changing the way the game is currently being played. The Rule 18 WP is looking for fleets willing to test a new rule 18 between May 1 and July 15, 2022. #### **CLINIC FOR RULE 42 ENFORCEMENT**

JETTS, the US Sailing Judges Education Training and Testing subcommittee, is developing a Clinic for rule 42 enforcement via Appendix P. The clinic's goal is to help beginning and intermediate judges get better at enforcing rule 42 on the water (hereon called rule 42). The best way to become good at rule 42 is through practice under the tutelage of an experienced judge, but our goal is to speed up that process with off-the-water training.

The clinic assumes little to no knowledge of enforcing rule 42. intermediate-level judges will find some good information as well.

When on the water with a more experienced judge, one gets to practice picking out violations from a group of boats, and likely, most of all, these boats will not be breaking rule 42. Because of this, one might not see a particular infraction throughout an entire event, so it can take a lot of time to program your brain with the necessary pattern recognition. We want to speed up that process by seeding your brain with knowledge of the rule through reading and discussion and video examples of some common breaches. We also hope to have videos of boat groupings within which boats may or may not be breaking rule 42.

In addition to reviewing the rules and learning from a video, the clinic will cover driving strategies so that the judges are seen and positioned at the most likely rule-breaking areas. Also covered will be the philosophy of giving the competitor the benefit of the doubt, which means the judges must be sure a competitor broke a rule before penalizing.

We could use more footage of boats that are possibly, but not necessarily, breaking rule 42 and video of boats in fleets. Our most likely source is coaches, so please let me know if anyone has that kind of video or knows of coaches who are willing to contribute. My email address is sailing@craigdaniels.com.

For those that don't have a rule 42 reference list, here it is. This is most of the required homework before the clinic. The quiz is an old World Sailing quiz, and we anticipate creating our own in the future.

# RACE ADMINISTRATION COMMITTEE

Greetings from the Chair of the Race Administration Committee,

SAQ - (Sometimes Asked Question, not to be confused with frequently asked)

#### (1) WTH is the Race Administration Committee?

The Race Admin Committee (RAC) is made up of the Chairs of Judges, Umpires, Race Officers, Classifiers, Measurers, Appeals, and Racing Rules. As defined in the Regulations (section 4.06, if you care), it "proposes products and programs that promote quality race administration, and coordinates the common activities of the committees within the Race Administration Office."

# (2) Where does the RAC fit into US Sailing?

The RAC is also a committee within the Race Administration Division (RAD). Said RAD is one of the 6 "Operating Divisions" defined in the By-laws (Bylaw 501). The Regulations define the RAD as being composed of all the abovementioned committees plus the RAC. The Chair of the RA Division also gets to be Chair of the RC Committee.

But wait, there's more.On the staff side of US Sailing, we have the Race Administration Office (RAO?). That is headed up by Matt Hill, staff member with the title Race Administration Director. And working under Matt is Judie McCann, Race Administration Coordinator.

In effect, the RA Committee/Division oversees the "volunteer side" of all things race administration related. And we work hand-in-hand with the "staff side".

#### (3) Why do I care as a Judge?

If you are only a Judge with US Sailing, then you can leave the above details to the Chair of the Judges Committee. But while each of our officiating disciplines has its criteria for certification, renewal, and training, there is a lot common in each discipline. Many of us have more than one certification, and keeping track of it all is (I think) unnecessarily complicated.

Secondly, I have found that regattas work best with the judges, race officers, umpires, classifiers, and measurers all understand, respect and work with each other - before and during an event. Working together, we can avoid a mess of problems (conflicts in NoR/SI, confusing clauses, confusing decisions) that can maximize the chances of a protest committee eating dinner during an event instead of conducting hearings all night. Succeeding at that involves all of us talking together.

#### (4) What is the RAC up to?

In 2020, the US Sailing Board formed a Race Administration Task Force to evaluate how Race Administration Division could meet its goals and what improvements could be made. That resulted in the "Race Administration Task Force Report" published in late 2020. It made a series of recommendations on improving training (including better training for our instructors), streamlining certification processes, improving communications both within the RAD and between RAD and its stakeholders, and promoting better leadership and recognition for our dedicated officials.
