Membership:

- The Holiday Pack program sold out (200 sales, \$33,754 revenue) in three weeks (11/21 12/7).
 - 72% of purchasers upgraded from a 1-yr membership term to multi-year.
 - 9% of purchasers are new members. This is significant as the program was not promoted outside of membership channels.
- Launched Org member renewal campaign in November.
 - 628 orgs (41% to budget) have renewed as of 1/15 for \$190,000 in revenue (43% to budget). Our goal is to reach 100% of the budget by May.
 - Updated MVP benefits are set to launch in February.
- Org members are currently signing up for Skill Up. Our updated Skill Up platform allows each
 org to customize the app to their brand and program format using US Sailing learning
 resources.
- Developing new member benefit for 65+ members with <u>Grouper</u>, an activity benefits manager, where members with Medicare+ and select other supplemental insurance can be reimbursed for their membership fee (up to \$100/year).
- Launched a new printed member card product on 1/3 and have sold 70 (\$1,500+) since the launch.
- New Keelboat Member Lifecycle communications are averaging 70% open rates, for reference the Weekly Lift has an 51% average open rate.
- Telltales member engagement program continues to gain steam.



- EOY finished strong with considerable closures and pledge payments in the past 3 weeks of the year. Unfortunately, some donors did not honor their commitments in 2023 which impacted our year-end numbers. We are still working on those lapsed pledges.
- 2024 started off on a strong note with several 5-figure gifts around the Olympic Trials.
- Broad-based appeals were strong this year vs. 2022, driven in large part by a diversity of
 messages and some innovative approaches. Nancy Isabel is analyzing our results there
 and allocating 2024 time and energy towards the highest ROI.
- We are working to establish new systems for collecting recurring payments, which build consistency in revenue and tend to multiply donor gifts.
- We will be on the road in Q1 hoping to leverage Marcus' start with the USST and meeting
 in-person with as many donors as possible to share our story and plans for this year and
 the coming Quad. Finding new donors and re-engaging with past donors is key!

Adult:

- The Adult Dept. says farewell and a hearty thank you to Nancy Mazzulli for 11 years of dedicated service to US Sailing and we are happy to welcome Diana Emmanuelli on board as the new Competition Manager. Diana currently works in the Education Department as an Education Coordinator.
- In 2023, 64 Safety at Sea in-person course were held. As of January 16, 46 Safety at Sea courses are on the calendar for 2024. More are expected to hit the calendar in upcoming weeks with this year being a Newport/Bermuda Race year and the 100th Anniversary of the Bayview Mac Race.

Youth:

Youth Competition

- Planning is well underway for 2024 events, including Championships, Junior Olympic Sailing Festivals, Youth Worlds qualifier regattas, and other clinics. US Sailing organized Learn-to-Skiff and Girls-Skiff clinics in 29ers are taking place in Miami, San Francisco, and Annapolis this spring, in partnership with coach Caroline Atwood.
- US Sailing staff have attended the last two USODA Opti National Team practices to interact with sailors, coaches and parents with the goal of connecting sailors to their next boat class after the Optimist.
- The US Youth Team competed at the Youth World Championship in Brazil in December 2023, winning a Silver Medal in the Nacra15 class and finishing in the top 10 in five out of ten classes. Phil Muller, Youth Performance Manager, served as team leader and head coach. Preparations for the 2024 Youth Worlds in July 2024 are underway.

Reach Initiative (STEM)

- The Reach Initiative (STEM) distributed 10 grants to 501(c)(3) youth sailing programs around the country. 2023 Reach Impact Report will be available January 2024.
- The updated 2024 Reach Initiative Grant online application and timeline will be available January 2024 with application due April 1,2024.
- The Reach Advisory Group (John O'Flaherty RI and Stephanie Webb FL) meet monthly to review current Reach resources and create a Strategic Plan for 2024-2026.

SEL Advisory Group

- The Social Emotional Learning (SEL) Advisory Group (Chris Childers CA, Whitney Kent WI, Melissa Gorchynsky CO) meet monthly to review past SEL resources from the Siebel Sailors Program 2019-2022 and create a Strategic Plan 2024-2026.
- There are two NSPS presentations dedicated to SEL, both facilitated by Staff Liaison Janel Zarkowsky Martin.

Community Sailing

- 2023 Community Sailing Awards recipients will be awarded in GA at NSPS 2024, with scheduled press release Feb 2024.
- 2024 Community Sailing Awards application and Selection Committee rubric have been updated with help from Community Sailing Committee Members Matthew Thompson MN and Stephanie Webb FL,
- One program is pending Community Sailing Accreditation and 11 have inquired about becoming Accredited.

Events:

NSPS

NSPS is shaping up to be a record-breaking event in both attendance and sponsorship! We look forward to welcoming over 400 attendees and guests to Savannah, GA. We are grateful for the 31 sponsors and 65 presenters without whom this event would not have been possible. Thank you to Savannah Yacht Club, our host local sailing organization for NSPS this year, they have rolled out the red carpet for us.

Over our three days in Savannah, we look forward to recognizing 23 individuals and organizations for contributions to the sport in various award ceremonies including the 2023 Rolex Yachtsman & Yachtswoman of the Year. We look forward to seeing everyone in Savannah!

Offshore:

All 3 measurement rules, IRC, ORC and ORR are up and running for 2024. We are busy processing certificates for winter races.

The Offshore Office has organized a series of roadshow events where the staff will travel and give presentations to sailors and event organizers to provide information that explains the measurement rules we manage and the best options for scoring races. And this is an opportunity for us to listen to our constituents and get feedback to potentially improve our services. Locales include Annapolis, St Francis, Bayview and Chicago Yacht Clubs with more to follow closer to home.

The Offshore Office is hosted a US Sailing Measurer's Training Seminar at San Diego Yacht Club. This seminar is an effort by the office to train more measurers in the Universal Measurement System (UMS), for the three measurement rating rules in the US, IRC, ORC, and ORR. The event is designed for current and prospective measures in North America.

US Sailing Measurer's Training Seminar – San Diego, CA – February 16-19th

Our work on revitalizing our services to PHRF continues. We are collaborating with PHRF volunteers on updating the online handicap database and designing a second service that will provide dimensional data for boats in their base configurations.

Race Administration:

2023 Seminar participants wrap up:

- Participation in race official training has continued to grow. In 2023 1103 individuals took part in 80 educational offerings. This is significant growth over the past two years (890 people/67 trainings in 2022 and 760 people/51 trainings in 2021).
- 260 race officials took part in 18 no-charge continuing education events.

The 25% membership dues discount for officials was well received, with more than 125 officials taking advantage of the offer in 2023.

As of January 19, the 2024 race official training calendar includes:

- 5 Advanced Race Management Seminars for 33 people (all in person)
- 18 Basic Race Management Seminars for 130 people (1 online)
- 5 Club Judge Seminars for 33 people (2 online)
- 1 Advanced Judge Seminar for 15 people (1 online)

• 18 Judge Roundtables, Clinics and Protest Days for 195 people (13 online)
Planning for a Race Administration National Faculty meeting in March in Bristol is under way.

Education:

2023 Course Metrics

- 145 new Keelboat Instructors were trained in 2023 this is nearly 150% of our annual goal. Standards for our instructors and programs continue to remain the best in the business.
- The Smallboat Level 1 course, which is our largest instructor course, saw a 21% increase in overall attendance in 2023 vs. 2022.
- Online education is still a hot commodity for sailors. Nearly 2500 people took either an
 online Basic Keelboat or Safety at Sea course last year. This online education
 supplements the invaluable in-person training received by students.

2024 Course Scheduling

- Eighty-Five (85) Smallboat Level 1 Instructor and thirteen Basic Keelboat Instructor courses have already been scheduled in 2024, with many currently hidden from the calendar to allow host clubs to register their own candidates. We continue to receive, and fill, courses daily.
- We intend to hold four separate Instructor Trainer (IT) courses in 2024, with the next one (a Level 1 IT course) occurring just prior to NSPS. Other IT courses will include a Small Boat Level 2 IT course, Basic Keelboat IT course, Reach Educator Trainer Course and potentially a Safe Powerboat Handling Instructor Trainer Course. In the last six months we have also on-boarded three new Cruising Powerboat ITs via a "co-teach."
