III. Approval of Minutes

The February Minutes were approved as written.

IV. Welcome and Announcements – Wayne Balsiger

- a. Thanks to Nancy Glover for helping with meeting notes.
- b. Credit to the IT department. The issue of Regional Judge not showing the expire date on the SOARS Admin report results has been fixed. This was quick as I pointed it out on Tuesday and several hours later it was fixed. It was like helped by having been submitted several times before.

- c. The BoD approved the Rule 69 Task Force Bylaw Amendment for Reg 15 update we requested and worked on. Matt sent today a copy of the update.
- d. I forwarded the US Sailing Volunteer Committee Review Task Force report.
 - i. In it you can see what the input was including mine and Bill Simon as committee Chairs. You can see the recommendations made by the Task Force. A 'Summit' coming later this year with Chairs to gather more granular feedback.

V. Race Admin Director Report – Matt Hill

- a. Update on LMS (Learning Management System) platform in late 2024: New Start Global and USSA have a draft contract. Approval is expected later this week. It is a three year contract (Matt to verify). The new build out of courses will begin in the fall of 2024. All courses must be "authored" again. Courses cannot be migrated. The Club Judge Seminar will be the first of the judge training to be updated.
- b. Update on insurance from National Association of Sports Officials: USSA is in productive discussions with the National Association of Sports Officials and their underwriter American Specialty Insurance regarding group pricing. Activities on land and on the water will be covered. Participants must be certified Race Officials. The current cost estimate is less than \$80 per year per person. This cost will likely be borne directly by the Race Officials. The JC wants at least some of the insurance cost covered by US Sailing.
- c. Matt gave an update on Review Board action status.
- d. Matt requested we all fill out the Conflict-of-Interest form recently sent to all Race Officials.
- VI. IJ Candidate Mentor Darryl Waskow: Arrangements for a US based IJ Seminar are currently being discussed with World Sailing. The location is still open. Darryl has a yacht club that may host the seminar in NY.

VII. Newsletter – Sarah Ashton

The May issue deadline is April 23.

- a. RRS 68; Chair report, Area D—Jerry, Rob Overton—Wayne, George Griswold—Nancy Z. There have been some complaints that the newsletter is too long, with 5+ articles. So, I will go with four unless there is a burning issue that is short and to the point. I am open to articles for next month.
- b. Someone mentioned having a "Judges' Town Hall." I would like to recommend we have another State of the Area Zoom meeting. A few years ago, it went very well for those RAJs who organized/ran one. Several areas had two to cover more people, which was more manageable. I, as chair, attended them. Chris Luppens and Mary Pierce are already moving ahead with this concept.

- VIII. Certification Requirements Craig Daniels
 - a. Minor update of February on Test period requirements. This topic was tabled until next session when Craig is able to attend.
 - IX. Terms of Reference Wayne Balsiger
 - a. Any edits? Are we ready to approve? Wayne states that this documents the JC functions and operating practices. Voted to APPROVE with yearly reviews at annual meeting for any updates needed.
 - X. Guidelines for Using RO Reports and Complaints Policy
 - a. This is designed as a guideline to help Race Officials understand and use the RO Reports and Complaints Policy, including tips for handling difficult conversations. JC voted to APPROVE. The document will be sent to Justin Sterk and the Race Administration Committee for consideration as guidance for all Race Officials.
 - XI. Judges at events without SafeSport Craig Daniels
 - a. In particular, I have noticed that at some events we have JITs (or UITs) that have no certifications. In fact, it is common at local events but I also saw it last year at the Opti Nationals. What should we do? The JC decided that current SafeSport policy is fine. WE REQUIRE SafeSport of all Race Officials, JITs and UITs. No further action.
- XII. RAJ recommendations for club judge
 - a. John Porter's proposed a RAJ may be a reference for a Club Judge. Motion APPROVED that a RAJ May act as a reference for CJ.
 - b. The Second paragraph, that a RAJ could provide a recommendation for RJs was TABLED.
- XIII. Recommendation when someone has worked multiple events together vs a single-event recommendation.
 - a. John Porter's proposal: APPROVED Multiple events may be taken into consideration. The 30-day deadline is desired but may be extended for good reason by the JC. These notes will be added as a couple of sentences to the certification requirements document.
- XIV. New Applications/upgrades
