The US Sailing Appeals Committee recently received an appeal of a decision of the Midwest Sailing Association (MSA) Appeals Committee which concerned a protest that arose from Race 2 of the 2006 F-18 National Championship Regatta conducted by the Carlyle Sailing Association on September 20, 2006. The protest was *F-18 590* vs. *F-18 2125*.

For several reasons we have decided to act under racing rule 71.3(c), National Authority Decisions, to "return the protest...for a new hearing and decision by...a different protest committee." Since the protest committee for an event is appointed by the organizing authority (see rule 89.2), the Carlyle Sailing Association as the organizing authority for the F-18 National Championship is responsible for appointing a new protest committee to replace the original committee.

You may find it useful to appoint one or more US Sailing National Judges to the new committee. We suggest that at least the chair be a US Sailing National Judge. As a first step you could contact the Regional Administrative Judge for your area; he or she can suggest names of judges and provide their phone numbers or addresses. The US Sailing website shows that Clifford Black is the appropriate Regional Administrative Judge and provides his contact information

(<a href="https://www.ussailing.org/competition/rules-officiating/judges/">https://www.ussailing.org/competition/rules-officiating/judges/</a>). Since the new protest committee will conduct a new protest hearing, it is important that none of its members be members of the original protest committee, and that none of the records of the original committee be made available to the new committee. The new committee will need the protest; however, the facts found and decision of the original committee must be removed from the protest form. The committee should contact the parties to the hearing; their names and addresses are enclosed with this letter. It may also wish to conduct the hearing by conference call.

This decision closes our File 06-11. By copies of this letter, the parties, the chair of the MSA Appeals Committee, and the chair of the original protest committee are advised that the decision of the new protest committee may be appealed as if it were the first decision concerning this matter.

We have received your appeal of the Lake Michigan Sail Racing Federation (LMSRF) Appeals Committee's decision on the protest *Independence* vs. *Convergence*, arising from an incident in Race 4 of the T-10 North American Championship on August 5, 2017, conducted by the Corinthian Yacht Club.

Rule R1.1(a) (which is a rule in the US Sailing prescription to Appendix R of *The Racing Rules of Sailing*) states, "To appeal the decision or the procedures of a protest committee or an association appeals committee, no later than 15 days after receiving the written decision being appealed...the appellant shall send an appeal and a copy of the decision being appealed to US Sailing. The appeal shall state why the appellant believes that committee's decision or its procedures were incorrect." The "decision" referred to in rule R1.1(a) is the written decision being appealed, which in this case is the decision of the LMSRF Appeals Committee dated October 20, 2017.

In your appeal, dated November 5, 2017, we find no statement or explanation referring to the LMSRF Appeals Committee's decision and stating why you believe its decision was incorrect. As you did not include in your appeal an explanation of why you believe the LMSRF Appeals Committee's decision was incorrect within 15 days of receiving it, we are unable to consider your appeal. If your appeal did include a statement saying why you believe the LMSRF Appeals Committee decision was incorrect, we are happy to have you point it out to us.
